



Racing Arizona LIVE Rules and Regulations

1. I understand and agree that this is an interactive game show adventure based on exploring Arizona on June 3 and 4, 2017 (the "Race").
2. I understand and agree that six teams will go on six separate adventures around Arizona.
3. I understand and agree that I will go to LIVE on Facebook and post pictures and videos of my adventures on the Race to show what is spectacular about Arizona.
4. I understand and agree to be at the finish line of the Race on 5th Street at Bliss/Rebar in Phoenix, Arizona, on Sunday, June 4, 2017.
5. I understand and agree that the winning team will be decided by likes, hearts, and shares on Facebook posts, not on the time in which I finish the race.
6. I understand and agree to adhere to Racing Arizona LIVE's three rules: (1) Racers cannot do anything illegal; (2) Racers cannot do anything immoral; and (3) Racers cannot do anything unkind.
7. I agree that my participation in the Race is entirely at my own risk.
8. I understand and agree to release and hold harmless Racing Arizona LIVE, CHESWORTH films, and Michael Chesworth together with any of their affiliates, subsidiaries, directors, officers, employees, representatives, licensees, agents, advertising and promotional partners, agencies and agents, sponsors, participants, and their respective successors, assigns, partners, directors, officers and employees (collectively, the "Racing") by virtue of or arising out of the Race, including the production, exhibition, distribution, promotion, and/or advertising of the Race, including without limitation, any claim of authorship or ownership, or for defamation, slander or invasion of privacy or infringement of rights of publicity. I further do hereby release, hold harmless, indemnify, forever discharge, and covenant not to sue the Racing and its affiliates, directors, officers, employees, contractors, members, partners, owners, predecessors, successors, assigns, and agents for, from, and against any and all liability, loss, claims, demands, causes of action, damages, costs, and suits of any kind or nature, either in law or in equity, which arise or may hereafter arise with Racing. I understand that this Release discharges Racing from any liability or claim that I may have against Racing with respect to any bodily injury, personal injury, illness, death, or property damage that may result whether caused by any act, omission, default, or negligence of Racing or its officers, directors, employees or agents, or otherwise. I also understand that Racing does not assume any responsibility for, or obligation to provide financial assistance or other assistance, including but not limited to medical, health, disability, or workers' compensation insurance in the event of injury or illness.
9. I hereby expressly and specifically assume the risk of injury or harm associated with the Race and release Racing from all liability for injury, illness, death, or property damage.
10. I understand and agree that I must have Comprehensive Automotive Liability Insurance covering use of all owned, non-owned, and hired automobiles used for purposes related to the Race for bodily injury, property damage, uninsured motorist and underinsured motorist liability with a minimum combined single limit per accident of one million dollars (\$1,000,000) or the minimum limit required by law, whichever limit is greater. I shall cause my insurers to name Racing as additional insureds on the insurance coverages. I also understand and agree to provide a copy of my insurance to Racing before the start of the Race. I understand and agree that Racing does not carry or maintain health, medical, disability, or other insurance coverage for me. I expressly waive any claim for compensation or liability on the part of Racing.
